Separate permits are required for electrical, plumbing, and mechanical work.

No changes shall be made from that which is stated in this application, or in attached plans and specifications. Granting of a permit shall not be construed as a permit for or an approval of any violation of the Building Code or any other state or local law regulating construction or the performance of construction. I further certify that all construction will comply with all adopted codes, ordinances, and that there may be a fee associated with obtaining a permit.

Notice to Contractors: The trade permit, for each respective trade discipline not associated with an already issued building permit, shall be issued prior to commencing work at the project location. Work commenced prior to permit issuance may be subject to additional fines and penalties. A permanent power inspection will not be allowed on any structure until the the structure in question has been "dried-in," is capable of being secured from unauthorized entry, the system grounding is installed and complete, the system service is installed and complete, and at least one GFCI protected circuit is installed.
